## Sessions

All eligible three and four year olds will be entitled to 15 hours free early education per week, for 38 weeks (term time) per year. At Whiteknights Nursery, this is currently offered as a minimum of five x 3 hour education sessions per week. You can choose from morning or afternoon sessions or a mix of all day, some morning / afternoon education sessions. The morning education session run 8.30am-11.30am and the afternoon sessions 12.30pm - 3.30pm.

From September 2017 a new entitlement will allow working families up to 30 hours free provision per week over a minimum of 38 weeks. Please see www.gov.uk for details.
